

## TERMS AND CONDITIONS FOR THE VODAFONE COMPETITION PACK

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES. PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE SUBSCRIBING to the "VODAFONE COMPETITION PACK". BY PROCEEDING WITH REGISTRATION/SUBSCRIPTION TO THE VODAFONE COMPETITION PACK, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS ("Terms and Conditions"), PLEASE DO NOT SUBSCRIBE TO THE VODAFONE COMPETITION PACK.

### Terms and Conditions:

The Vodafone Competition Pack (also referred to as "Competition Pack") is organized and hosted by OnMobile Global Ltd., a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India, ("OnMobile" or "Organizer") and is open for subscription for active1 prepaid and post-paid category of Subscriber(s) 2 ("Subscriber(s)") of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter collectively referred to as "Vodafone India") residing in India and within the following Vodafone India telecom service areas ("Circle(s)")-ANDHRA PRADESH, ASSAM, BIHAR, DELHI, GUJARAT, HARYANA, HIMACHAL PRADESH, KARNATAKA, KERALA, KOLKATA, MAHARASTRA, MADHYA PRADESH, MUMBAI, NE, ORISSA, RAJASTHAN, WEST BENGAL, UTTAR PRADESH EAST, UTTAR PRADESH WEST, JAMMU & KASHMIR, PUNJAB, CHENNAI & TAMIL NADU. By subscribing to the Competition Pack, You indicate Your acknowledgement and acceptance of these Terms and Conditions.

Procedure and Eligibility for subscription:

**1. Eligibility:**

The Competition Pack is open for subscription for all active Subscribers who fulfil the following criteria:

- Subscriber must be of or above 18 years of age;
- Subscriber must be a resident of India;
- Subscriber must belong to any one of the Circles mentioned herein;
- Subscriber must be an active Vodafone India Subscriber;
- Subscriber must not have been either convicted and / or prosecuted for commission of any criminal offence nor be of an unsound mind; and Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship.

**2. To subscribe to the Vodafone Competition Pack:**

- a. The Vodafone subscribers have to call 5670330 (Toll Free) (“IVR”) or Dial the Unstructured Supplementary Service Data (USSD) string \*567\*899# or SMS ACT LAKH to 144 or 199 (Toll Free) or press 1 through Out Bound Dialers (“OBDs”).

Subscription to the Competition Pack is completely free.

As soon as a Subscriber sends a subscription request:

Through USSD/SMS, he/she will receive an acknowledgement on his/her number registered with Vodafone India telling him/her that his/her subscription request has been received.

By pressing 1 through OBD/IVR, he/she will be informed that his/her subscription request has been received.

Once the Subscriber has successfully subscribed through any of the above mentioned methods in clause.

**2. (a)**, he/she will get an SMS informing about the current or upcoming competition, prizes to be won and the competition that can be played at just Rs.5/ or Rs. 3 or Re. 1 per day, depending on the balance available on his or her Vodafone India number.

All Competition Pack Members will be sent regular SMS updates and details about the current and the upcoming competitions, informing about the prizes and charges with the terms and

conditions URL of the specific competition. The SMS will contain the method of unsubscribing from the Competition Pack, so that the Subscribers are educated about the same.

The Organizer and Vodafone India shall not be liable for any reason whatsoever in the event the Winners respond or communicate in any form, with any other number. In the event the Winners do not answer the calls of the Organizer, an SMS will be sent to the MSISDN of the Winners intimating them regarding their winnings and providing them the details as to how, when and where they can collect their respective prizes ("Intimation"). The prizes must be claimed by the Winners within 30 days from the date of Intimation to the Winner, failing which, the prize(s) will be deemed to be forfeited by the Organizer, under the respective categories under the Competition. 7. By subscribing to the Competition Pack, you confirm and waive the applicability of rules and regulations of the National Do Not Call Registry and You agree to receive promotional messages and alerts including without limitation daily updates on the score under the current competition and updates about current and upcoming competitions from the Organizer, as it may in its sole and absolute discretion decide.

8. By subscribing to the Competition Pack, the Competition Pack Member consents to the following information relating to them to be exchanged between Vodafone India, OnMobile and their concerned vendors and/or published or otherwise communicated to in any media that the Organizer may deem fit, for the purpose of Winner announcement for each competition organized under Competition Pack: name, mobile phone number, score and/or photograph ("Information"). 10. The Organizer, at its sole discretion, may or may not provide a cash alternative to any of the prizes being offered in any of the competitions that are launched as a part of Competition Pack.

11. All prizes offered in any of the competitions of Competition Pack are subject to availability. Organizer reserves the right to provide alternate models or brands for any of the prizes without prior intimation or consent of the participants of any competition under the Competition Pack.

12. 14. Such act of providing incorrect information, concealing or withholding any information, including

e. 17. The employees of Vodafone India, OnMobile and their group companies, affiliate or associate companies shall not be eligible to participate or win any of the prizes offered in any of the competitions launched as a part of the Competition Pack.

18. These Terms and Conditions are subject to force majeure circumstances including without limitation, floods, natural disasters, war, act of terror, political unrests, technical snags, act of God or any circumstance beyond the reasonable control of Vodafone India and/or OnMobile ("Force Majeure Event"). Neither OnMobile nor Vodafone India shall be liable for any delay or adverse effect caused to Competition Pack or any competition(s) thereunder as a result of a Force Majeure Event. OnMobile and/ or Vodafone India shall intimate the suspension of Competition Pack or any competition thereunder caused as a result of such Force Majeure Event to the Competition Pack Members and the subscribers to individual competitions.

19. In the event of any discrepancy between these Terms and Conditions and the terms and conditions of any specific competition, so far as the same impact the terms and conditions of subscription to Competition Pack as are specifically provided hereunder, the Terms and Conditions hereof shall prevail. In the event of any such discrepancies impacting the terms and

conditions of any specific competition only the terms and conditions of that particular competition shall prevail and override these Terms and Conditions.

20. Subject to any applicable law (a) warranties of any kind whatsoever, whether express or implied, are hereby expressly disclaimed by Vodafone India and/ or OnMobile including, but not limited to, meeting of the Competition Pack Members or Subscriber's requirements or aspirations, timeliness, security, the results or reliability of any competition, or the delivery, quality, quantity, merchantability, fitness for use or non-infringement in respect of any goods, services, benefits or awards acquired or obtained through any of the competitions of Competition Pack or any transactions effected through Competition Pack; (b) The Subscriber expressly agrees that his/her participation in the Competition Pack or any competition thereunder offered by Vodafone India is at the his/her sole risk and is governed by the Terms and Conditions herein; and (c) No advice or information whether by representations, oral, written or pictorial derived from the Website or through Competition Pack shall be construed to mean the giving of any warranty of any kind by Vodafone India or OnMobile.

21. Vodafone India, OnMobile or any of their group entities or affiliates, their respective directors, officers, employees, agents, representatives, shall not be liable for any loss or damage whatsoever that may be suffered, or for any personal loss or injury that may be suffered (including loss of life), by a Competition Pack Member and/or any third party, directly or indirectly, by use or non-use of the prizes offered in the individual competitions offered under Competition Pack.

22. Vodafone India and/ or OnMobile may assign any or all of their rights under these Terms and Conditions to their affiliates without consent of the Competition Pack Members.

23. The Competition Pack Members participating in each individual competitions under Competition Pack shall indemnify and keep indemnified Vodafone India and OnMobile and their officers, directors, employees, customers, affiliates and agents harmless from and against any and all claims, losses, suits, proceedings, action, liabilities, damages, expenses and costs (including attorney's fees and court costs) which OnMobile or Vodafone India may incur, pay or become responsible for as a result of breach or alleged breach of the representations or obligations of the Competition Pack Members under the Terms and Conditions hereunder or under the terms and conditions of the specific competition, any failure by the Competition Pack Member participating in an individual competition to comply with applicable law and any third party claim in respect of misuse of any information of a third party. Vodafone India and OnMobile shall have the right to defend themselves, pursuant to this Clause, at the cost of the Competition Pack Member. The Organizer, Vodafone India or their respective affiliates shall not be responsible for any direct, indirect, incidental, special, punitive or consequential damages, including loss of profits, incurred by the winner or any third party, whether in connection with Competition Pack, any competition thereunder or otherwise.

24. Nothing in the Competition Pack including the individual competitions organized there under shall affect any intellectual property right of Vodafone India or OnMobile in any product

or service, which may be the subject matter of the individual competitions, which shall, at all times, remain with Vodafone India or OnMobile, as the case may be.

25. This offer under the Competition Pack cannot be used in conjunction with any alternative offer or promotion of similar nature.

26. These terms are subject to guidelines/ directions issued by the Department of Telecommunications (“DoT”), Telecom Regulatory Authority of India (“TRAI”) or any other statutory authority from time to time.

27. The decision of the Organizer in respect of all transactions/issues pertaining to the Competition Pack shall be final and binding on all Competition Pack Members.

28. Neither the Organizer nor Vodafone India shall be responsible for any claims arising out of technical failures before, during, between or after the completion of any competition in the Competition Pack, including but not limited to any technical failures in the telephone lines, mobile connectivity, any action that has been initiated, actioned or completed through the Subscriber's mobile phone, failure of servers or the failure to provide the correct competition score updates or any mistakes arising out of technical snags or resultant inability of the listener for participation. Further, neither Vodafone India nor the Organizer shall be responsible for any claims arising out of any failure(s) which is beyond the reasonable control of the Organizer or Vodafone India.

29. The Competition Pack Member(s) hereby agrees and undertakes not to hold the Organizer, Vodafone India and/or any of their group entities or affiliates, their respective directors, officers, employees, agents, vendors, responsible for or liable for, any actions, claims, demands, losses, damages, costs, charges and expenses, either direct or remote that the Subscriber may/might have suffered, sustained or incurred, or claim to suffer, sustain or incur, by way of and /or on account of the Competition Pack or any related competitions.

30.
